

RELEASE AND ASSIGNMENT

This Release and Assignment (“**Release**”) concerns photographs, recordings, videos, testimonials, biographies and/or renderings or derivatives thereof (whether in analog, digital, video, film, or any other form), including any associated sound recordings or documents transmitted, created or processed directly or indirectly for or in connection with United Nations Framework Convention on Climate Change (COP30) event (“**Initial Purpose**”), that (1) bear my name, image, voice and/or likeness, whether alone or with third parties, and/or (2) were personally created by me (collectively, the “**Materials**”).

Release and Assignment:
